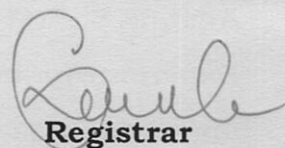
**Agenda 11:Information on Endowment of Manorama and Sitharamalyengar Research Award**
